The lust for power And its harmful consequences



we aren't the ugliest of all. On Transparency International's 2005 index of perceived corruption, out of 158 countries, Afghanistan ranks 117 and we fare somewhat better.

Any war needs a strategy and it's impossible to fight corruption with 500.000 civil servants to regulate and control our overegulated ... market economy.

So, the first step should be to reduce this frightening crowd of public employees, but the crowd gets larger and I'll give you a sample α shipping is the jewel of our economy and our global pride. Our foreign trading fleet is the largest but we are in want of a national policy that will secure a good number of national marine Officers, keep Vessels in our Registry and apply the Maritime Cluster Concept, as every maritime nation does, and the E.U. strongly suggests. Our Shipping Minister established a new government branch under the name "Institute of Maritime Training" (I.M.T) to do what several hundred people in this Ministry already do.
